Sealed offers duly completed should reach us at the above address along with a Demand draft towards, EMD Amount of **Rs.2,000/-** (Rupees Two Thousand only) drawn in favor of **HMT Ltd.,Auxiliary Business Division, payable at Bangalore on or before 2.00PM, on 12.09.2022** at HMT Auxiliary Business Division, Jalahalli, Bangalore—560013. **Tenders will be opened on 12.09.2022 , at 02.30 PM.** Tenderers or their authorized representatives may remain present at the time of Opening tender.
- II. Offers shall be addressed to the '**Dy. Manager (C & E), HMT Ltd., Auxiliary Business Division, Bangalore -560013**'. Envelopes containing tender must be properly sealed with WAX or Cello tape and **super scribed with the following :-**

Tenders shall be put in Tender Box placed at the Office of General Manager (ABD), HMT Ltd., Auxiliary Business Division, Jalahalli, Bangalore –560013. Postal delay if any, shall not be considered.

1. Cost of the tender document is Rs.300/-.Tender document may be downloaded from HMT web site www.hmtindia.com/tenders , www.eprocure.gov.in. If the tender is downloaded a DD for an amount of Rs.300/-payable to HMT Ltd, ABD towards the cost of the tender documents should be enclosed along with the tender, failing which the offer will be rejected.
2. The license period is five years. Every year 8% increase in license fee shall be charged over and above the preceding years license fee.
3. Applicable GST and Statutory levies shall be charged as per norms, during license period.
4. Successful tenderer is required to execute License Agreement in the prescribed format to be furnished by HMTL- ABD on stamp paper as per Stamp Act as fixed by Government of Karnataka at licensees cost, before occupation of the premises.
5. The premises shall not be used by licensee for any purposes other than the one mentioned by the licensee in the Tender, except with the approval of HMTL.
6. Allotment letter will be issued only for the Shops as specified by the tenderer in the Tender and no changes in the allotment will be entertained at any point of time.
7. The licensee shall be responsible for the upkeep and maintenance of the property and surroundings at his own cost.
8. No additions, alterations are allowed by the licensee without the written approval of the HMTL / Licensor. Premises shall not be sublet to others. If sublet to others the license fee shall be doubled and also action will be taken as per the Public premises (Eviction of Unauthorised occupants) Act 1971.
9. Incomplete/Conditional/Delayed offers and without EMD shall be liable for rejection.
10. The EMD of the unsuccessful tenderers will be refunded without interest after finalizing the offer to the successful tenderer on production of EMD paid receipt.
11. In case of successful tenderer the EMD will be adjusted towards Security deposit. However, if he/she fails to take the possession of the premises within one week from the date of receipt of allotment order, EMD shall be forfeited by the Company.
12. **Ten months license** fee shall be paid to HMTL ABD as refundable Security Deposit by the licensee, which will not carry any interest. If the tenderer fails to occupy the shop/execute agreement after depositing Security Deposit, allotment will be cancelled and 3 months license fee shall be recovered.
13. The Electricity and Water connections, if required shall be provided by ABD at the prevailing rates of BESCO & BWSSB as per actual consumption. However, necessary piping, cabling/meters etc., shall be arranged by the tenderer at his cost.

14. Permission/ License if required to run the business shall be arranged by the licensee only at his cost from the Competent Authorities.
15. The Licensee shall have no right whatsoever for continuation of the License beyond the period fixed under this License Agreement under any circumstances and shall vacate the premises/schedule property without overstaying the agreed License period. If the Licensee fails to vacate the licensed premises upon expiry of the license period for any reason whatsoever or sublet the shop to outsiders, the Licensee shall be liable to pay to the Licensor the penal license fee which shall be **double the amount of license fees being paid by the Licensee**, for the immediate preceding month of default/lapse/omission/commission. However, if the licensee does not vacate the premises even after 6 months from the date of expiry, then the licensor reserves the right to charge the licensee additional penalty as deemed fit for the period of over stay. This remedy / penal provision, shall however, be without prejudice to the rights of licensor to evict the licensee in accordance with the provisions of the Public Premises (Eviction of Unauthorized occupants) Act, 1971 or through any other legally permissible means/norms.

17. Multiple offers from sister concerns or related concerns having common ownership/links with each other are strictly not allowed. In that case their offers will be rejected straight away.
