1. The License Agreement would be initially for 11 Months, which can be further extended for Eleven Months and so on each on term to term basis subject, to satisfactory services, conduct and behavior.
2. The successful tenderer will have to deposit six month rent including earnest money of Rs. 10,000.00 already deposited with the tender with the Company as security. The same would be refunded after the termination of agreement and after adjusting dues if any. The deposit will not carry any interest whatsoever.
3. The Electricity charges would be as per the reading/actual consumption at the prevailing commercial rates of U.H.B.V.N.
4. The payment of all Taxes, Levy by the Government/ Statuary Body including GST as applicable from time to time shall be the responsibility of the Licensee.
5. The agreement shall stand automatically terminated on the expiry of License/Agreement unless extended. In the event of termination of contract the Licensee shall hand-over the vacant possession of the scheduled property in good condition to Estate Officer, HMT Limited, Pinjore. Any damaged, loss or deformation caused to the scheduled property shall be made good by the licensee or in case of failure to do so the amount based on prevailing cost of repair/replacement of such damaged, loss or deformation including administrative charges would be recovered from the Licensee in default. However the Furniture, Fixture equipments etc. installed by the Licensee may be removed by the Licensee itself as its own cost with in 24 hrs. of the expiry/termination of License; failing which the Company will have absolute power to take the possession of the scheduled property and the Licensee will loose its right/claim on its left out items.
6. Upkeep, maintenance and cleanliness of the Shop and surrounded areas shall be responsibility of the Licensee.
7. The Licensee shall not make any structure/alteration of any type, temporary or permanent, without prior written approval of Estate Officer.
8. The Company under no circumstances shall be liable for any or every kind of damage/loss to the scheduled building/business of the Licensee or for any accident or injury occurred arising there.
9. Any alteration or interior decoration, if required, shall be undertaken by the Licensee after obtaining proper approval of the Estate Officer, HMT Limited, Pinjore and the same would become the property of HMT Limited on termination of the License.
10. The Licensee shall obtain all the necessary Govt. permission required for running of the business in said Shop at its own cost.

11. The Licensee shall take at its own cost necessary fire and other types of insurance required during occupation in their own interest.
12. The shop will be allotted “**as is where is basis**”. Maintenance of shop will be the sole responsibility of the Licensee.
13. For proper implementation of the terms and conditions of the agreement, the Licensee shall be fully responsible to the Company’s authorized representative for the purpose and the authorized officials of the Company shall at all reasonable hours would be allowed to inspect the premises to ascertain bonafied use and state of repairs and maintenance of building etc.
