General Terms and Conditions of Notice Inviting Tender for Hiring of Vehicles on Contract basis

1. The vehicles offered should be in a good condition and well maintained / road worthy, the model of the vehicle should be 2019 onwards with valid permit issued by the competent Authority.
2. The quality and condition of the vehicle should be acceptable to HMT MTL, General inspection will be carried out by HMT representative for assessing the Quality and Condition of the vehicle.
3. The initial contract is valid for Two Years and extendable yearly for further two years (Maximum total period of contract for 4 years) upon satisfactory performance.
4. The copy of Vehicle Registration Certificate, Driver License, Aadhar Card, Road Permit, Valid Insurance Certificate, Emission Certificate etc. should be available in the vehicle at all times and copy of the same to be submitted to HMT.
5. Rates mentioned should be inclusive of fuel / oil / tax / driver wages / maintenance / insurance etc.
6. Toll Charges and parking charges will be paid extra as applicable on production of valid documentary proof and the company is not liable to pay any other charges other than these.
7. Applicable TDS will be deducted as applicable from monthly bills of the travel agency.
8. The Driver should possess valid driving license issued by the RTO.
9. The driver should know the local language (Kannada) and should be well mannered.
10. The Driver should wear Uniform preferably White / Khaki dress while on duty or as per RTO rules time to time.
11. In case of break down due to unforeseen circumstances, an alternative vehicle/s of equal model should be provided immediately. In case the travel agency fails to provide a substitute vehicle immediately, double the hire charges will be recovered for the period of non provision of substitute vehicle from the monthly bill of the agency.



12. The Driver of vehicle must be in a position to render the services as per the requirement of HMT Machine Tools Limited. Working Hours are fixed on time to time basis depending upon the requirement of the work.
13. Payment Terms : Payment will be made within 30days of submission of monthly bills duly certified by Transport-in-charge. The bills/claims should be submitted to the Transport Department at HMT MTL, Bengaluru Complex.
14. The tenders invited for rendering services is for 26 days in a month. However, in case of any increase / decrease in working days payment will be made on pro-rata basis for the increase / decrease in working days..
15. Utilisation of vehicles will be calculated on actual kilometers basis from the reporting time to closing / reliving time including extra kilometer if any as per the rates agreed. Vehicles reporting at HMT MTL / Exit at HMT, Bengaluru complex will be calculated based on the actual kilometer from the factory. Vehicles reporting directly to the pickup point, Kilometer will also be considered.
16. The Owner/ Driver of the vehicle must ensure the employees safety while travelling and safe guard the company's property if any during transit. In case of damage or loss or theft of goods etc., during transit the same shall be borne by the owner / Driver of the vehicle.
17. The driver and the owner should ensure to maintain a Log Book indicating commencing / starting time, closing time and number of KMs travelled and signature should be obtained from the Officer(s) who used the vehicle for the Official purpose.
18. The successful tenderer should enter into an agreement with HMT MTL, Bengaluru Complex regarding the terms and conditions specified herein and any other terms, agreed upon. within a week from the date of issue of work order.
19. The successful tenderer will be intimated details of timings to render their service on all working days separately at the time of awarding the contract.
20. In case of variation in the cost of fuel, the escalation of the cost will be calculated on the basis of formula given below:

$$\frac{\text{New rate per litre} - \text{Old rate per litre}}{\text{Average Mileage per litre (*)}} = \text{Difference of rate per KM (Actuals)}$$

(\*) In case of Goods Tempo average mileage will be considered 10 Kms and for Autorickshaw average mileage will be considered 20 Kms for calculation.

21. Security Deposit:

21.1 The Successful tenderer shall have to pay Rs. 12,500/- as security deposit for Goods Tempo and Rs. 7,500/- as security Taxies for Auto rickshaw for the due fulfillment of the contract. The security deposit will be returned after successful completion of the contract without interest on deposit. The security deposit will be forfeited if the services are not provided as per the terms of contract.

21.2 In case the successful tenderer does not start the operations as per the contract or backs out from the contract the EMD amount / Security Deposit paid by him will be forfeited.

22. Likely commencement of the contract will be from 01.08.2024. However it will be confirmed.

23. The Company reserves the right to extend the term of the contract or to short close the contract at any time, without assigning any reasons or the contract can be terminated by giving three months advance notice from either side. The contract will also be cancelled if performance is not satisfactory.

24. Quotation should be free fom CORRECTIONS / OVERWRITING.

25. HMT reserves the right to negotiate with L2 to match with L1 price, in case L1 backs out from contract.

26. The service provider shall comply with all statutory obligations like ESI, PF, Payment of wages Act, Bonus, Labour License , liability Insurance on men and material, Tools and plants, Machineries and equipments etc. at their cost and risk. HMT shall be in no way liable for such risks.

27. Where counter terms and conditions of business are offered by parties, HMT Machine Tools Limited, Bengaluru Complex shall not be deemed to be governed by them, unless specific written acceptance thereof agreed by HMT Machine Tools Limited, Bengaluru Complex.

28. DISREGARD OF ANY INSTRUCTIONS MAY RESULT IN YOUR OFFER BEING REJECTED.
