## GENERAL TERMS AND CONDITIONS FOR LICENSING

### 1. Eligibility

Central Government Depts./Autonomous Bodies under Central Government/CPSEs, State Govt. bodies/ State PSUs/ Private bodies/ Organizations/ MNC.

### 2. Location

The properties proposed for licensing is located in Praga Division, C.I.E., Gandhinagar, Balanagar, Hyderabad – 500037. The property is offered on "As is Where is" basis.

### 3. Licensing Term

3.1 **Licensing Period:** For a period of 4 Years 11 Months.

3.2 **Renewal of License:** Subsequent renewal is subject to mutual understanding / fulfillment of all tender terms & conditions and approval of Competent Authority.

### 4. Application

Sealed offers in the prescribed Application Form along with all pages of this Tender Document including General & Special Terms & Conditions should be signed in token of acceptance and submitted in original to The Manager(Ay) & a/c - Estate, Civil & ED, HMT Machine Tools Limited, Praga Division, C.I.E., Gandhinagar, Balanagar, Hyderabad – 500037 on or before **28.03.2025**. Tenders received without sealed cover and in other mode of submission such as fax, email etc., shall not be considered.

### 5. Site Inspection

Inspection of premises may be made on any working day between 10.00 AM to 3.00 PM. Bidders may contact Manager(Ay) & a/c - Estate, Civil & ED for the purpose and familiarize themselves with other details of the property.

### 6. TECHNICAL BID

The Tenderer's shall enclose copies of all the relevant documents / certificates as specified in the Technical Bid format. If the concerned document / certificate is not applicable to the bidder, the same shall be written specifically with reasons by the tender. No column in Technical Bid shall be left blank.

6.1. **EMD and tender form cost DD's shall be enclosed with Technical Bid only.**

6.2. The tenderers whose offers satisfy the Technical details prescribed will be qualified for opening of Commercial Bid. Date and time of opening Commercial / Price Bid will be communicated to the technically qualified tenderers.

6.3. Tenderers whose Technical Bids are not found suitable will not be eligible to participate in opening of the Commercial / Price Bid.

6.4. Any correction / overwriting etc. should be initialed by the Tenderer.

6.5. Technical Bid without EMD and tender cost amount will be rejected.

**7. Commercial Bid / Price Bid:-**

- 7.1. The License Fee shall be quoted by the Tenderer in the Commercial / Price Bid application form only.
- 7.2. The Successful Tenderer shall deposit 12 months license fee as Security Deposit with the Company before executing / registering the license agreement within 30 days after the receipt of the offer letter. The licensing agreement will be executed only after the receipt of the security deposit. The licensee/ allottee will be permitted to occupy the premises only after execution / registration of the license agreement. In case, the successful Tenderer does not accept the offer and does not pay security deposit / execute license agreement with the Company within a period of 30 days from the date of allotment, the allotment will stand cancelled and the EMD of such Tenderer will be forfeited. If the Tenderer fails to register / execute the agreement after depositing Security Deposit, allotment will stand cancelled and three months license fee shall be recovered from Security Deposit amount. However Management may at its discretion permit the Tenderer to execute / register agreement within a grace period of 15 days beyond the permitted period provided Security Deposit has been paid within permitted period from the date of allotment. In that case payment of license fee shall be chargeable from the date of expiry of 30 days from the date of allotment. Failing to execute / register the agreement with grace period also, allotment will stand cancelled and three months license fee shall be recovered from Security deposit amount, apart from forfeiture of EMD.  
  
The Security Deposit does not carry any interest and will be refunded to the Licensee on vacating the premises as per License Agreement after adjusting the dues, if any,
- 7.3. In case, successful tenderer withdraws his offer after opening of Commercial Bids his EMD amount will be forfeited.
- 7.4. The EMD in respect of the unsuccessful bidders will be refunded without interest after finalization of tender.
- 7.5. The Licensor or the Licensee will have the right to terminate the License (Agreement) by giving three months advance notice from either side or payment of three months license fee prevailing at the time of termination in lieu of notice.
- 7.6. The successful bidder shall execute / register the License Agreement with all the terms & conditions mentioned in the draft Agreement approved by the Licensor. The Stamp duty & registration charges, if any for the License Agreement shall be borne by the Licensee, as provided under Telangana Stamp Act. The premises are given on license "As is where is basis" and the licensor will not be responsible for any repair / renovation work etc., during the license period.

8. **Rights & Responsibilities of Licensee**

- 8.1. The Licensee shall not use the premises offered for any other purpose except for the purpose for which it is allotted.
- 8.2. The Licensee will have to handover the property and structures made on allotted site to the Licensor after the expiry of license period, such structures if any shall become company's property and to be left behind.
- 8.3. The Licensee will have to pay the monthly license fee every month on or before 5th regularly. Failing which the penalty will be charged at the rate of minimum 0.25 % per day or maximum 5% of the rental value as decided by the company.
- 8.4. The Licensee shall also be required to pay the charges for consumption of water and electricity separately as per his consumption during the License period as per the rates fixed by the Company along with GST if any, if the same has been provided by the company. The existing power can be used by paying the Electricity charges regularly, however, if any additional power is required, licensee shall make arrangements for additional power. Licensee shall, make arrangements for installation of Energy Meter for metering of the electricity consumption. If the said facility i.e. water and electricity is not available the licensee shall make own arrangement for power and water supply.
- 8.5. The Licensee shall keep the said premises in good and tenantable condition at all times during the License period and deliver the same including electrical and other fittings, fixtures, appliances, equipment, furniture etc. if any, back to the Licensor in good conditions on expiry or termination of the License else such cost will be recoverable from security deposit.
- 8.6. The Licensee shall not carry on any offensive trade or business in the licensed premises/schedule property, nor shall they store or carry out any activity, which is prohibited by law.
- 8.7. The GST / applicable taxes and other statutory requirements shall be levied wherever applicable as per norms applicable during license period in addition to rent.
- 8.8. The licensee will not be allowed to make any structural alterations to the building, except for interior modifications, for all major modifications the licensee has to take prior permission of the licensor with such terms and conditions mutually agreed upon. After the expiry of the license period, such alterations, if any shall become company's property and to be left behind. Any modifications / additions / changes done to the premises etc., even though carried out with licensor's prior permission, the Licensee should not claim the cost for such modification / additions / changes on HMT Machine Tools Ltd., Praga Division during or after expiry of the License period. No such claim shall be entertained by HMT Machine Tools Ltd., Praga Division.

- 8.9. The Licensee shall indemnify the Licensor against all actions, claims, demands and expenses on account of any breach by the Licensee, of any of the terms of the License and shall allow the Licensor or his representatives to inspect the said premises offered on License at all reasonable times for satisfying themselves that all the terms & conditions thereof are being observed by the Licensee.
- 8.10. The Licensee is required to maintain the said premises in good condition and undertake to complete any repairs whenever warranted at his cost and to keep the premises in usable / good conditions.
- 8.11. The Licensee shall be responsible for the security and safeguarding of the premises during the tenure of the License. The cost of premises / building will be provided at the time of agreement. The Licensee shall arrange a comprehensive insurance cover policy in favour of the company, for the Premises and the properties inside the premises and shall provide a copy of the said Policy to Licensor. The Premium to be paid by the licensee.
- All statutory requirements with respect to 'Fire protection' as per prevailing laws in Telangana, including Insurance cover, shall be the responsibility of the licensee, licensor is no way shall be responsible towards any fire related accident (if any) or any type of accidents / untoward incidents in the premises including payment of damages / compensation etc.. The Licensee shall allow authorized representative of Licensor for inspection of the conditions of the premises as and when required.
- 8.12. In the event of there being any change in the constitution / legal status of the Licensee, the Licensee shall immediately notify about such change along with all relevant documents, approvals etc. for approval of the Licensor. In case such change of Constitution is not accepted by the Licensor, the License shall stand terminated, in which event the Licensee shall, within 30 days, vacate the premises without giving room for initiating any legal action for vacating or other proceedings available under law.
- 8.13. It will be the responsibility of the licensee to obtain necessary license, permission if any from the concerned authority or body, at their cost before commencement of the activity in the premises and keep such license etc., valid at all times and also comply pollution control norms as per the govt. directives.
- 8.14. The licensee shall allow authorized representative of licensor for inspection of the conditions of the premises as and when required.
- 8.15. Right of Way: Approach to the property in existing condition shall be given to the Licensee. They have to construct their own Roads inside the allotted land and enclosure / Boundary wall where ever required.

**9. Rights and Responsibilities of Licensor**

- 9.1. The Licensor shall enable the Licensee to use the premises offered on License basis without any interruption or disturbance from the Licensor subject to the conditions of license agreed to by the Licensee.
- 9.2. The Licensor will not, in any way, be responsible for any transactions carried on between the Licensee and their Customers / Suppliers or any other constituents related to the employees / persons employed by them.
- 9.3. Company / HMT Machine Tools Ltd., Praga Division reserves the Right to accept or reject any or all Tenders without assigning any reason what so ever.
- 9.4. It is clearly understood that the transaction does not contemplate transfer of interest of any kind in the said premises to the Licensee under the License, but only a permission to use the premises for the purpose stated by the Licensee in the tender submitted by them.
- 9.5. The Licensee shall have no right whatsoever for continuation of the License beyond the period fixed under License Agreement under any circumstances and shall vacate the premises / schedule property without overstaying the agreed License period. If the Licensee fails to vacate the licensed premises upon expiry of the License period for any reason whatsoever, the Licensee shall be liable to pay to the Licensor the penal license fee which shall be twice the amount of license fees paid by the Licensee, for the immediately preceding month of default. However, if the licensee does not vacate the premises even after 3 months from the date of expiry, then the licensor reserves the right to charge the licensee additional penalty as deemed fit for the period of further over stay. This remedy / penal provision, shall however, be without prejudice to the rights of licensor to evict the licensee in accordance with the provisions of the Public Premises (Eviction of Unauthorized occupants) Act, 1971 or through any other legally permissible means / norms., after the expiry of license period.
- 9.6. The Licensee cannot sublet the premises in part or full which is licensed to him, if found the Licensee agreement will be terminated without any notice and action will be initiated as per the law.
- 9.7. Throughout the License period, the Licensee shall have the sole and exclusive use and occupation of the licensed premises and except on there being a breach of the agreed terms and conditions of the License.
- 9.8. The Licensee can take out the moveable items brought by him only while vacating the premises and all fixed items have to be left behind.
- 9.9. There shall be 7% increase every year (License year) over license fee of preceding year, till the duration / terms of this license.

- 9.10. The Licensee has to comply with all statutory and other applicable Acts in force, from time to time to run the Business.
- 9.11. Multiple offers from sister concern or related concern having common ownership / links with each other are strictly not allowed. In that case their offers shall be rejected straightaway.
- 9.12. All corrigendum(s) if any, to this Tender shall only be posted on website <https://eprocure.gov.in>, <https://www.hmtindia.com> and <https://www.hmtmachinetools.com> and will not be notified through press advertisement.
- 9.13. In the event of any liability arising under law in force from time to time or any claim arising for any reasons involving contractors staff due to accident or any other account such liability shall be borne by the licensee and HMT Machine Tools Ltd., Praga Division shall in no way be responsible or liable for the same.
- 9.14. Interested parties may visit / inspect the premises between 10 AM and 3 PM on all working days up to **28.03.2025** with prior permission from The Manager (AY) & a/c - Estate, Civil & ED.
- 9.15. Any person / agency has filed any case or raised any litigation against the company which is pending before any court is not eligible to apply for the tender.

#### **10. Penalty Clause :**

- 10.1 In the event of the Licensee failing to pay the monthly license fee beyond 2 months, action will be initiated to vacate the said premises forthwith without any further notice and shall be liable to hand over the vacant and peaceful possession of the premises to the Licensor. Otherwise action will be initiated as per Public Premises (Eviction of Unauthorized Occupants) Act 1971. The Licensor reserves the right to re-enter and take possession of the premises, in accordance with the provisions of the said Act.
- 10.2 For non compliance of condition may amount to termination / recover of cost. The Unit Chief / General Manager of Company is the final authority for deciding on the matter.
- 10.3 In the event of any dispute between the Parties in respect of interpretation of any of the terms of the License Agreement or any issue or matter or dispute arising out or connected with the License granted, or of the License Agreement, the same shall be referred to the Sole Arbitrator appointed by HMT Machine Tools Ltd., Praga Division and the provisions of Arbitration and Conciliation Act, 1996, shall apply to such arbitration and the decision of the said Arbitrator will be final and binding on both the parties. The Arbitration proceedings shall be held at Hyderabad jurisdiction only and the language of Arbitration is English.

## 11. Licensing Procedure

- 11.1 Bidding for part qty. can be accepted if there is no offer for full qty. of tender.
- 11.2 The minimum bid price per annum should be at least 6% of prevailing circle rate / guidance value of the property and / OR allotment will be done on the basis of the highest licensing bid price.
- 11.3 Allotment shall be made in the name of the Bidders only. No nominee(s) of the allottees shall be entertained.
- 11.4 The property will be allotted on “As is where is basis” only.
- 11.5 Allotment once made shall not be altered.
- 11.6 The land & Building areas indicated in this bid document is subject to actual measurement and payment shall be made on the basis of actual measurements.
- 11.7 The Licensing of the property will be done on the basis of highest tendered (H1) / negotiated price provided that the price is considered reasonable by HMT Machine Tools Limited, Praga Division and the decision in this regard by HMT Machine Tools Limited, Praga Division shall be final and binding on the Parties.

## 12. Earnest Money Deposit (EMD) and Tender Document Cost

## 13. Possession

**16. Mis-representation or suppression of facts**

If it is found that the applicant has given false information or concealed certain facts, the allotment is liable to be cancelled without making any reference to the applicant and all deposits made until then shall be forfeited.

**17. Arrangement of Power, Water Supply and Sanitation**

The licensee shall make their own arrangements for power, water supply and sanitation at site wherever company is not able to provide the same.

**18. Approvals**

All approvals required in respect of Licensing / registration of the property and its development and compliance with statutory requirements will have to be obtained by the Licensee. However, HMT Machine Tools Ltd., Praga Division, Hyderabad will give necessary co-operation, if required, to the extent possible. All costs & fees including registration, stamp duty & others, if any will be borne by the Licensee.
