- 2.5 Tools, material, fittings & equipments, chain pulley, infrastructure required for extracting and lowering of pump motors out of borewells for repair works, motor replacement etc to be arranged by the service provider including transportation etc and no charges for the same will be paid by the company,
- 2.6 All required tools, materials, equipments required for operations & maintenance of water supply at borewells/ watersupply lines/main water storage tank to be provided by the service provider for their staff including hiring of JCB for any faults/repair works/ damages, chokes/blockages for underground water pipelines & supply of material etc,
- 2.7 Required stock for taking up subject services of water supply to be arranged by the service provider and party to undertake any other work that may become incidental or connected with the above as assigned by the Engineer- in- charge from time to time.

3. Log Books

- 3.1 Log books/Registers are to be maintained for pumping of water at each tubewell/borewell & storage tank, office in the approved format.

3. Log Books

3.1 Log books/Registers are to be maintained for pumping & other operations at inlet & outlet of the STP in the approved format.

4. Testing

4.1 All the parameters of effluents at outlet of Sewerage Treatment Plant shall be maintained as per the norms/parameters of the Haryana State Pollution Control Board as per IS:2490(Part-1-1981) before discharge of effluents. - c. The Service provider to ensure buffer stock of one number water reservoir at all time to meet the emergency requirement like in case of any fire, breakdown etc,

C. Co-ordination with UHBVN & other Govt. bodies
